A neuropathological examination of the human brain in cases of amnesia is presented, and examples of the psychopathology of memory are provided. The final chapter analyzes amnesia from a medicolegal point of view.

This monograph will be of interest to clinicians, neurologists, psychiatrists, psychopathologists, psychologists, and medicolegal practitioners.
