En cuanto al procedimiento penal, tiene sus reglas en el Código Nacional de Procedimientos Penales al regular sus etapas debidamente delimitadas en las de investigación, con sus fases de investigación inicial y la judicial; la etapa intermedia, que comprende las fases escrita y oral; a la conclusión de ésta surge la etapa de juicio oral, considerada como el momento medular de todo el procedimiento, pues se dicta sentencia, en la cual se elimina el sistema tasado de valoración de la prueba para condenar o absolver.

Por último, el autor expone las habilidades estratégicas para el uso de las técnicas de litigación oral para realizar los alegatos, el interrogatorio, el contrainterrogatorio, las objeciones, así como las reglas para la introducción de la prueba material o evidencia física.
